### Message of Pál Schmitt, President of Hungary

Budapest, March 21st, 2012

Hungary's attention yet again turns to Latin America. In the past two decades our Central and South American, and Caribbean partners have become more and more deprioritized in our foreign policy. We wish not only to stop but also to reverse this trend.

The Hungary-Latin America Forum taking place in Budapest and organized by the Ministry of Foreign Affairs is a perfect occasion not only to review the possibilities of our bi- and multilateral cooperation, but also to draw the attention of the international public opinion to the significant achievements of both Hungary and this important continent. It is my firm belief that the dynamic economic and social development of Latin America and Hungary's renewal and reorganization since 2010 offers countless opportunities for cooperation. Therefore, I am confident that the scope of our relations will be widened and expanded into new dimensions as a result of this Forum.

Hungary's dialogue with Latin American countries is justified by the fact that both Hungary and the Latin American countries are firmly striving to find adequate answers to the current international political and economic challenges both in a national and global framework.

An outstanding figure of Hungarian history, Count István Széchenyi often cited two hundred years ago the great personalities of the Latin American independence wars, especially Bolivar and San Martin, to those, who did not recognize the necessity for change in time. Just two decades ago Latin American and Central Eastern European countries – with Hungary in a leading role – realized a successful political and economic transition through enormous efforts, mutually paying attention to each other's paths of development.

All conditions are currently given to utilize these rich experiences and results of the transition to the advantage of an even more fruitful economic and political cooperation between Hungary and Latin America.

Being a Central European country Hungary is one of the newer members of the European Union. The development of our Latin American relations enables our region to undertake a greater role in the forming of the EU-Latin America relationship. We are therefore glad to share the results of this Forum with the countries of our region: we are especially glad that representatives of the Czech Republic, Poland, and Slovakia have also accepted our invitations to the forum.

It is my firm belief that the Hungary—Latin America Forum is the beginning of a process, which will be followed by further steps leading to the revitalization of our Latin American relations.

I wish all the participants a good conference, and advantageous experiences!

### Greetings by János Martonyi, Minister of Foreign Affairs

Budapest, March 21st, 2012

It is my great pleasure to welcome you to the first Hungary-Latin America Forum. This new initiative provides a unique platform for diplomats, business leaders, scientists, and NGOs from our countries to reinvigorate and strengthen ties between Hungary and Latin America.

This initiative is both very important and timely. Ours is a fast-changing world that is becoming more interconnected and more global than ever before. We are watching with great appreciation the spectacular rise of certain regions around the world. In response to these trends, Hungary is readjusting its foreign policy to be more open to global developments. As part of this effort, we are reassessing Hungary's relationship with Latin America.

Based on our shared values and the importance we attach to our cooperation, Latin America has always figured prominently in the EU's vision of the 21st century world. However, the intensity and strength of ties between Latin America and various EU member states differ greatly. While the EU has traditionally benefited from the strong links between some of the member states and Latin America, there is still a lot of unrealized potential for growth in cooperation between Central Europe and Latin America. Despite the geographic distance, similar challenges and dilemmas we have faced in certain phases of our histories have created a special link between our region and Latin America.

During the past two years, the countries of Latin America have achieved an average economic growth rate of 5,2 per cent, their exports increased by 27 per cent and attracted 20,7 per cent more foreign direct investment. This dynamic economic growth of Latin America and the increasingly important role the countries from that region play in world affairs is a positive development that also provides good opportunities for increased cooperation.

The concentrated efforts at a successful integration into the Euro-Atlantic structures led to an unintended weakening of our previously intensive ties with Latin America. Therefore, the potential for improvement is huge and we have made the decision to reverse the trend by injecting new substance into our relationship. I hope that this Forum will generate a momentum for enhancing our economic, political, cultural, and scientific ties.

A more interlinked and globalized world also means more common responsibilities and global challenges that can only be met together. Hungary is looking for closer cooperation with Latin America in addressing some of the key global and regional issues of our age.

Not acting on these recognitions would be entirely our loss. Implementing the vision of Hungary and Latin America coming closer together and doing more would be an important gain that is worth all the efforts that are required to make that happen. We sincerely hope that our friends in Latin America can share this approach.

I am confident that this forum will fulfill its mission by helping to realize the underutilized potential in greater cooperation between Hungary and Latin America and mark the beginning of a more substantive and intensive relationship between a renewing Central European country and one of the most dynamic regions in the world.

I wish all of you a productive and interesting conference.

### Hungary-Latin-America Forum Draft Program Budapest, March 21-22, 2012

A major shift has been taking place in the world economy and world politics over the past decade. In light of these global changes, Hungarian Minister for Foreign Affairs János Martonyi introduced last December the new priorities of Hungarian foreign policy in a new strategic document entitled "Hungarian Foreign Policy after the EU Presidency". Among its most significant new dimensions, the new strategy treats global opening and the strengthening of our regional policies as key priorities. In this spirit, Hungary is opening up to regions that have been less emphasized or forgotten by Hungarian foreign policy in recent years as well as to certain sub-regions with which diplomatic relations have not been established yet (the Caribbean, Sub-Saharan Africa, and the Pacific Islands).

In pursuit of this global opening and of significant foreign trade priorities, Hungary has announced a new start for rebuilding its relations with Latin America. The Hungary–Latin America Forum is jointly organized by the Ministry of Foreign Affairs, the Ministry of National Economy, the Ministry of National Resources, the National Innovation Office, the Hungarian Institute of Foreign Affairs, and the Hungarian Investment and Trade Agency. The event is taking place on March 21-22, 2012 and it will include three thematic forums and a plenary session.

The invited participants are the Latin American countries with diplomatic accreditation in Hungary (7 countries with Embassies in Budapest: Argentina, Brazil, Chile, Cuba, Ecuador, Mexico, and Venezuela, and the 5 countries with accreditation from Vienna: Colombia, Guatemala, Peru, Paraguay, and Uruguay). The Directors for Latin America and the Directors for Strategic Planning of the Ministries of Foreign Affairs of the Czech Republic, Poland and Slovakia have also been invited alongside representatives of the European External Action Service and the EU–Latin America Foundation.
