DUTIES AND RESPONSIBILITIES

Under the overall supervision of the Director, AGS, and the direct supervision of the Senior Officer, Agro-food Industry Group, the incumbent will participate in the development and implementation of programme activities relating to socio-economic and managerial aspects of agro-food processing industries and post-harvest systems in developing countries. In particular, the incumbent will:

- analyze socio-economic issues, strategies and programmes to support the development, increased efficiency and improved
 impacts of agro-food processing industries and post-harvest systems in developing regions; assist FAO Members through
 reviews and provision of technical advice;
- participate in developing guidelines relating to socio-economic and managerial aspects of agro-food processing and post
 harvest systems development, including profitability appraisals, feasibility and competitiveness studies and contractual and
 partnership arrangements
- appraise capacity building needs relating to the development, increased competitiveness and improved impacts of agro-food
 processing industries and post-harvest systems; assist in developing training materials and participate in the conduct of
 training courses;
- participate in the design and implementation of programmes and projects relating to agro-food processing industries and post-harvest systems development; as requested, provide technical backstopping to field projects;
- contribute to the collection and dissemination of data and information related to trends on socio-economic and managerial
 aspects of agro-food processing industry and post-harvest systems development globally, including lessons and good
 practices for promoting and supporting development in these areas; support exchange of information and data through the
 Internet and other mechanisms;
- prepare information materials and technical papers for discussion and/or publication; prepare and participate in technical meetings;
- develop and maintain contacts with other organizations, associations and private sector firms working on agri-food processing and post-harvest systems in developing regions;
- perform other related duties, as required.

MINIMUM REQUIREMENTS

Candidates should meet the following:

- University degree in agricultural engineering, food technology or a related field supplemented by formal studies (post-graduate or advanced level degree) in agribusiness, agricultural economics or business management
- Five years of relevant experience in the areas of agro-industry development, post-harvest systems or agri-food industry economics and management
- Working knowledge of English, French or Spanish and a limited knowledge of one of the other two or Arabic, Chinese or Russian

Candidates will be assessed against the following:

- · Extent and relevance of experience in agro-industry development, including in developing countries
- Extent of knowledge of post-harvest, agro-processing, food loss and food waste issues
- Extent of experience in developing and implementing projects and programmes on agro-industry development, post-harvest handling and value added transformation, in developing regions
- Extent and relevance of experience in producing reports, technical papers and training materials in areas relevant to the position
- Quality of both oral and written communication skills on technical issues
- Capacity to work in a team and to interact with government and industry stakeholders
